The owner agrees to pay the daily boarding rate of \$22.00 per calendar day for one dog, \$19.00 per day per dog if two or more dogs will be boarding and \$14.00 per day for one cat, \$11.00 per day per cat if two or more cats will be boarding. Other small animals will be charged a rate of \$10.00 per day. If pet(s) are picked up before 10:00am Monday thru Saturday you will not be charged for **that one day** your pet is being picked up (Sundays are excluded as we do not open until 2:00pm).

The owner further agrees to pay any and all costs incurred by Holiday Kennels Company including but not limited to boarding and grooming services, medication administration, pick-up and delivery services, veterinary care, walk and playtime services and any other special services requested.

The owner authorizes Holiday Kennels Company to seek whatever emergency medical care may be necessary while we care for their pet(s). The owner's veterinarian will be selected when possible to provide care unless it is an emergency situation or after hours care is necessary. The owner will be responsible for reimbursement to Holiday Kennels Company for all medical costs.

Holiday Kennels Company will not provide boarding services unless the owner makes available current vaccination documentation for our records.\*By signing this contract the owner certifies that all information provided to us about their pet(s) is accurate and true.

\*Required Immunizations for dogs are: DHLPP (Distemper, Hepatitis, Leptospirosis, Parvovirus, Parainfluenza), Bordetella and Rabies.

\*Required Immunizations for cats are: FVRCP (Feline Viral Rhinotracheitis, Calicivirus, Panaleukemia), FELV (Feline Leukemia Virus) and Rabies.
